## Beverly Hills, WeHo Pavilions stores to be sold under merger

■ Property owner plans development at Olympic site

Grocery giants Kroger and Albertsons in 2022 announced a merger that would combine two of the largest supermarket operators in the U.S. under one umbrella. The deal would see Kroger – which

owns Ralphs – acquire Albertsons – which owns Vons and Pavilions – for \$24.6 billion, the largest merger of its kind in history. However, the mega merger was challenged by the Federal Trade Commission with a lawsuit that alleges the plan would

## Council determines if Roxbury trees get the ax

■ Appeal hearing on tree removal set for Sept. 10

After the Beverly Hills Planning Commission on June 26 granted a tree removal permit for a private property at 1001 N. Roxbury Drive, neighbors filed an appeal of the decision, which will be heard by the City Council on Sept. 10. The permit approved the removal of three heritage trees – two Coastal Redwoods and one London Plane Sycamore – as the property owner plans to construct a new home on the empty lot.

Heritage trees are defined by the city as trees with a circumference of 48 inches or more, and removal requires a permit granted by the city. The two Coastal Redwoods on the property are 94 and 107 inches, and the London Plane Sycamore is 75 inches in circumference. The Planning Commission, in its decision, added a condition that the trees must be replaced with three trees each at least 25 feet tall at the time of planting.

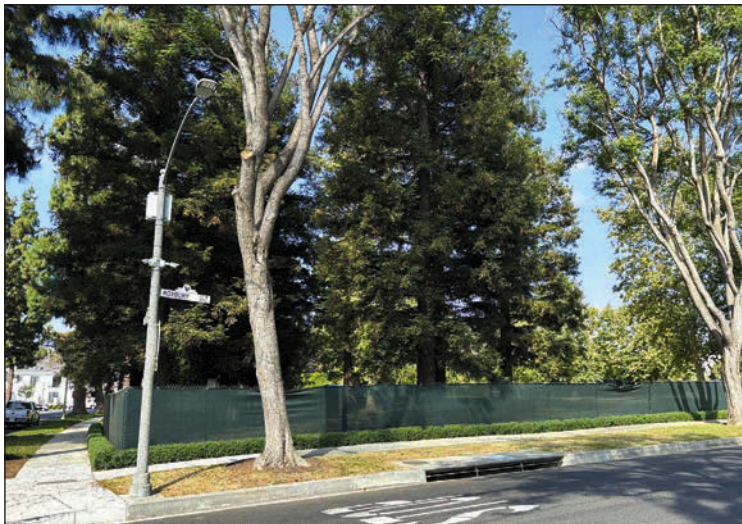

The appellant, Maple Leaf Ventures, LLC, alleges that the Planning Commission's findings are not supported by evidence, that the decision violates the California Environmental Quality Act and that the city did not provide legally required notice to surrounding property owners. The appellant has also argued that the removal of the trees negatively

impacts the surrounding area.

"The loss of the trees will result in significant adverse environmental effects through the loss of canopy cover, habitat and other ecological, aesthetic and historic benefits. Substantial evidence shows that the trees provide irreplaceable environmental benefits, and their removal will adversely

## WeHo 'swamp' stews sanitation concerns

■ City presses owner to clean up site of stalled project

The Melrose Triangle has become a focal point of concern for West Hollywood residents, as an abandoned construction site between Santa Monica Boulevard and Melrose Avenue has become what many have coined a "swamp."

A six-story mixed-use development has been stalled on the property for over three years – though excavation had already begun, which is why the property is now a giant subterranean pit. Stagnant water has led to muddy, swamp-like conditions, creating concerns over mosquitos and pests.

"We are aware of the issue and our technicians have conducted multiple mosquito inspections and treatments over the last month," said Aaron Arguay, the executive

director of the Los Angeles County West Vector Control District. "Follow up inspections [and] treatments will be conducted as needed until the project manager can eliminate the standing water problem."

The city of West Hollywood issued a statement on the problem, saying that the city is "actively responding to community concerns" about the site, which is located on the 9000 block of Santa Monica Boulevard.

"The city's neighborhood and business safety division has opened a code enforcement case and is working with the property owner to ensure that dewatering takes place at the property, which is in a high water-table area," the statement said.

The code enforcement team issued a violation notice to the property owner, listed as the Charles Company, on June 24.

"Dewatering pumps are now fully operational and, according to the property owner's representative, additional dewatering pumps will be activated to expedite drainage," West Hollywood's statement continued.

The project manager for the Charles Company did not respond

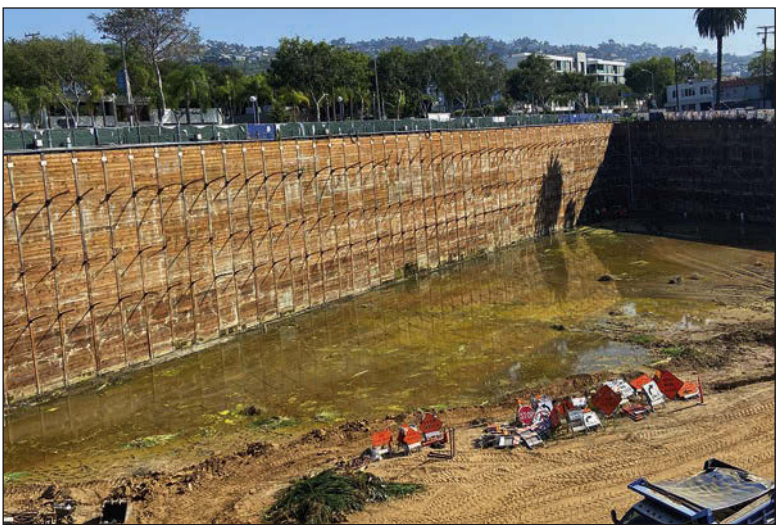

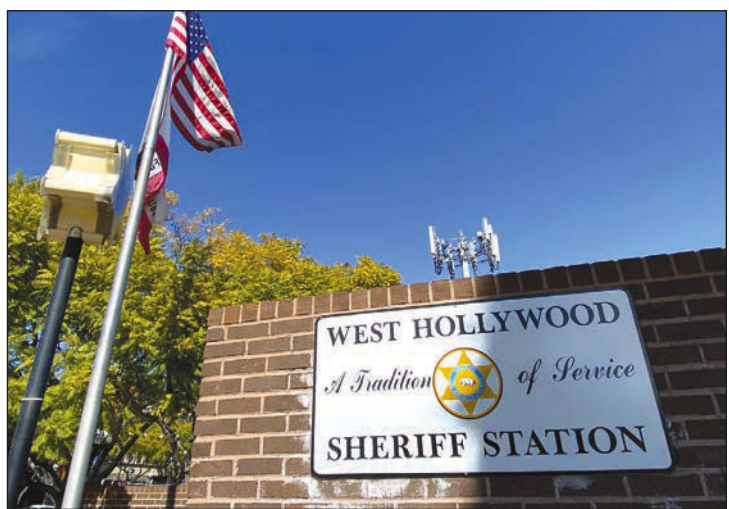

■ Council approves new public safety measures

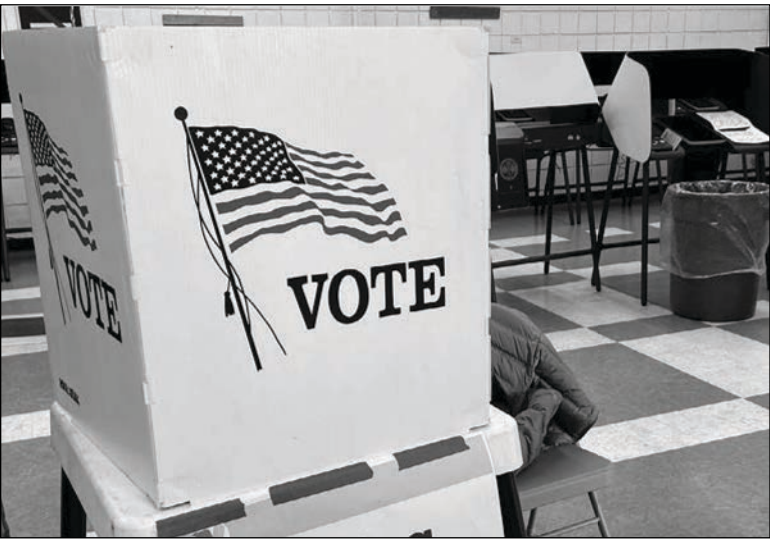

# Candidate filing period opens for Nov. 5 general election

Los Angeles County Registrar-Recorder/County Clerk Dean C. Logan announced that the candidate nomination filing period for the Nov. 5 general election is now open. Candidates are required to file and return completed paperwork to the RR/CC Headquarters on or before 5 p.m. on Friday, Aug. 9. If nomination documents for the incumbent are not filed by that time, the nomination period for persons other than the incumbent will be extended to 5 p.m. on Aug. 14. Candidates who want to file paperwork in person are encouraged to make an appointment before vis-

iting the RR/CC Norwalk Headquarters. Appointments can be made online or by calling (800)815-2666, option 4. Alternatively, candidates may request that their paperwork be issued to them by email or U.S. mail if they request it in advance of the deadline. Candidates interested in running for office are encouraged to review the Nov. 5 candidate handbook and resource guide. The handbook and resource guide include a variety of details and critical deadlines for being eligible for the election. For information, visit lavote.gov.

# WeHo Council election off to the races

■ Candidates pull papers as nomination process begins

The West Hollywood City Council election has officially begun. On July 15, candidates started submitting nomination papers. As of July 17, six candidates have taken the first step toward entering the race, with more expected in the coming days.

The deadline to file is Aug. 9 at 5 p.m., although that date is expected to be extended to Aug. 14. The filing period is extended if at least one incumbent does not file, and Councilwoman Sepi Shyne previously shared that she would not be seeking reelection. Mayor John Erickson, however, was among the first to enter the race. Shyne and Erickson currently hold the two seats that will be open in the Nov. 5 election.

So far, the candidates, in addition to Erickson, are business license commissioner Danny Hang, Block Party WeHo owner Larry Block, Los Angeles County employee Rachel Schmeidler, resident Ramesses II Setenpre and William West Seegmiller, founder of the Free WeHo Coalition, a self-described “medical freedom advocacy and support group.” Public safety commissioner George Nickle has also announced his intention to run, but has not yet picked up his application from the city clerk.

“I was the first person to announce in this run for City Council, and I am excited to pull my papers this week,” Nickle said. “While I am not a career politician, I am honored to take part in the democratic process and look forward to winning in November and establishing a new commonsense majority on City Council that will be responsive to the public safety concerns of residents and small business owners.”

Hang cited his desire to increase AAPI representation as a key reason for his decision to run for office.

“For decades, Asian Americans have been underrepresented in positions of leadership. By stepping up to run for office, I aim to bridge this gap and ensure that the concerns, perspectives and aspirations of the Asian community are heard and are a part of the decisions that impact our lives. It’s time for our government to reflect the rich diversity of our city,” Hang said.

Like others running, Hang said that there are issues in West Hollywood that “deserve attention and action.”

“Right now, we’re facing an intense housing crisis. Across the city, our neighbors are struggling to remain housed. Hard-working community members face skyrocketing rents and impossible homeownership barriers. I’m committed to championing policies that will protect renters, make it easier to build affordable housing and ensure that everyone has a roof over their head,” Hang said.

Schmeidler said that her background as a 24-year resident, single mother, renter, special needs advocate and “real-world government experience” working as a principal accounting systems analyst for the Los Angeles County auditor-controller has uniquely prepared her to serve on the council.

“West Hollywood is a vibrant and diverse community, and I am committed to ensuring it remains inclusive and safe for all residents,” she said. “I aim to enhance public safety by reinvesting in our sheriffs and implementing collaborative and constructive solutions to address any community concerns. I also see a great need to support our local businesses, reduce regulatory burdens to foster economic growth and modernize our rent stabilization programs to protect renters and maintain the unique character of our neighborhoods while supporting smart growth. I am passionate about advocating for those with special needs and creating pathways for employment for people with disabilities. This commitment stems from my personal and professional experiences and drives my dedication to community service.”

Schmeidler also cited the upcoming 2026 World Cup and 2028 Olympic games as important upcoming events in which a candidate with skill would be necessary to help prepare West Hollywood for the influx of visitors and opportunities the events will bring.

“I am running because I want to leverage my experience, skills and passion to make a positive impact

on the city I love and help our West Hollywood thrive for years to come,” she concluded.

Seegmiller discussed his desire to bridge differences with others in his candidacy.

“After years of division in West Hollywood, [it] marks the start of a new chapter as we pull nomination papers for the 2024 City Council race,” Seegmiller said. “This year brings an exciting mix of candidates beyond the usual establishment names. I’m proud to run as the only independent and am honored to be joined by other grassroots leaders challenging the status quo. As national divisions are likely to intensify ahead of November’s election, let’s remember that after it’s all over, we will still live with one another. I hope that West Hollywood can exemplify loving our neighbor, even as we respectfully disagree.”

Block said he was running because “the streets are dead.”

“Business is terrible. Customers come in to my shop and ask what happened to WeHo,” Block continued. “I do not see another candidate who understands the impacts of council decisions on small business. I’m running because City Hall is broken and many decisions are made without due process. I’m running to bring a resident centric small business voice to the City Council.”

Both Erickson and Councilman John Heilman encouraged candidates to get familiar with the city’s civil practices.

“It would be great to see some of the individuals running attend a City Council meeting to learn how and why we do things, but I want to

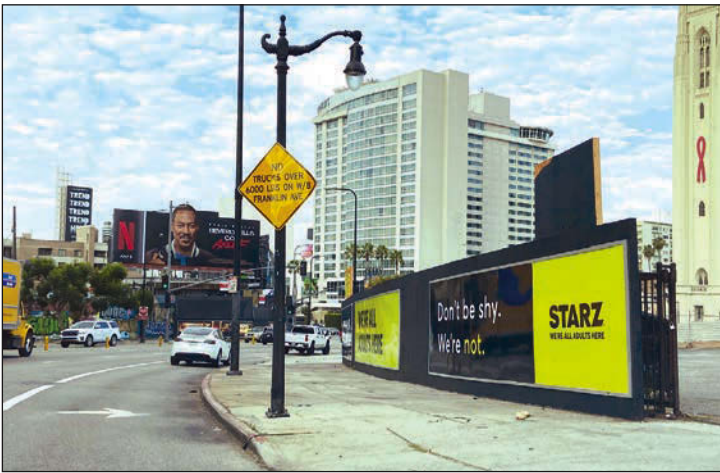

# Cleanup at encampment on Highland brings relief

The sidewalk on the west side of Highland Avenue north of Franklin Avenue was cleared on July 15 by a city of Los Angeles cleanup operation at the site. As of July 17, tents that had largely blocked the public sidewalk in front of a fenced parking lot on Highland Avenue had not returned.

The cleanup was a CARE+

operation scheduled by the office of Los Angeles City Councilwoman Nithya Raman, 4th District, and was part of a comprehensive effort to get people off the streets and connect them with services, Raman’s spokeswoman Stella Stahl said. CARE+ operations, which involve sidewalk pressure washing and sanitization, are conducted periodically to ensure health

# Man sought for unprovoked attack on Melrose Avenue

LAPD Wilshire Division investigators are searching for a male suspect who violently attacked a female victim on June 24 on Melrose Avenue near Crescent Heights Boulevard.

Lt. Mark Ro said the attack was unprovoked. The victim was walking her dog when the male suspect, who was shirtless, crossed the street and began following her. Ro said the suspect walked up from behind and punched the woman in the face, causing her to fall. The suspect then walked away.

“We believe he is homeless and was suffering from mental illness issues. He didn’t say anything to the victim but she said he was mumbling something,” Ro said. “A witness was driving by in a car and saw him hit her but didn’t get a good look at the suspect. The witness pulled over and helped the victim and called police.”

Investigators found security camera footage of the suspect as he crossed the street shortly before the attack and released it to

the public. The victim, Sigal Engelberg, posted the video of the suspect on social media and asked the public to help find him.

“Please share this video so he can be caught. Keep a lookout and call the cops if you see him,” she posted on July 12 on Instagram.

Ro said patrol officers viewed the footage and have been looking for the suspect. Ro said personnel who frequently contact unhoused individuals do not recognize him and have not been able to identify the man.

“It’s very bothersome. It doesn’t happen often, but we’ve seen situations occur throughout the city where someone walks up and just punches a victim,” Ro said. “It’s egregious, especially when it’s unprovoked.”

Authorities said anyone who sees the suspect should call 911. Anyone with information is asked to call Wilshire Division detectives at (213)922-8205 or (213)473-0476. During week-ends and off-hours, call the LAPD’s hotline at (877)LAPD247.

# LAPD seeks suspects in Hancock Park burglary

Police are searching for four male suspects who burglarized a home in the 400 block of South Las Palmas Avenue in Hancock Park on July 14 and are searching for additional security camera footage that may lead them to the perpetrators.

The burglary occurred in daylight, around 11:10 a.m. Lt. Mark Ro, with the Los Angeles Police Department’s Wilshire Division, said the suspects were waiting in a parked car in the neighborhood before committing the crime. The resident told officers he left around 10:30 a.m. and received a notification from his alarm system shortly after 11 a.m. that a side door was opened. The resident called police, and so did a neighbor who saw three suspects exiting the residence around 11:09 a.m. carrying property belonging to the victim.

Ro said the suspects wore masks and hooded sweatshirts, making it difficult for authorities to get a good description. Security camera video was found in the neighborhood that shows the suspects’ car, but the license plate was covered. The vehicle is a gray 2024 four-door Honda Accord, he added.

No similar burglaries were reported during the past week in the neighborhood, but Ro said the crimes occur frequently, with burglary crews targeting different neighborhoods. He said the resident told investigators that he left a side door unlocked on July 14 and he cautioned people to keep doors and windows secured. Ro also said

alarms are helpful in preventing crimes, and cameras help police identify suspects.

“It’s usually multiple suspects covered from head to toe who go in when residents aren’t home and take what they want and flee,” Ro added. “This general area does get hit from time to time, mostly north of Third Street and east of Gower in the Olympic Division.”

Cindy Chvatal-Keane, president of the Hancock Park Homeowners Association, said a similar burglary occurred in the neighborhood around two weeks ago.

“It’s something that is occurring all over the city, they happen all the time,” Chvatal-Keane said. “It’s very unfortunate.”

Chvatal-Keane pointed out that a permanent senior lead officer from the Wilshire Division has not been assigned to the Hancock Park area since Officer Dave Cordova retired

earlier this year. The station’s administration assigned Office Phil Choi to serve as temporary senior lead officer, but he recently returned to regular patrol duties.

Ro said administrators are in the process of getting a permanent senior lead officer assigned to the area but the decision is made by the department’s Personnel Division, and it is unclear how long it will take.

“We basically have to get a green light from downtown until we can fill the vacancy,” he said. “That doesn’t mean we are not deploying resources to the neighborhood. Officer Choi is still deployed to the neighborhood and is working the area. We are also deploying other resources.”

# Commission approves five-story Doheny building

■ Project will bring one affordable unit to Beverly Hills

The Beverly Hills Planning Commission on July 11 approved a development plan and density bonus permit for a five-story residential project at 232 S. Doheny Drive.

The commission approved the project in a 3-0 vote. Commissioners Gary Ross and Lou Milkowski were not present at the meeting.

The project will replace a single family home on Doheny Drive with a multifamily residential building. The building will contain nine units – eight market rate and one reserved for affordable housing, which allows for a density bonus permit. While a building at that address would typically be restricted to six units, the affordable housing unit allows for a density bonus of three additional units under state housing laws. The building will be 53 feet tall with a rooftop lounge area open from 7 a.m.-9 p.m. Plans also include four surface-level and nine underground parking spaces. The building is designed by architect Jamsheed Sobhani.

“Our goal is to improve the area and to make it more desirable, more livable. And I think that’s what we’ve done in this particular project,” the project’s attorney Murray Fischer said during the meeting.

Though the developers believe the project will improve the quality of life in the neighborhood, some nearby residents expressed concerns with the plans in written public comments.

“We have lived here since 1998 and since then there has been ever-increasing development in a large way with less and less parking, carelessness of developers who have no interest whatsoever to keep our community preserved in a positive way,” Sami and Lauren Ibrahim wrote. “It is a shame that such a community has become interested in developments that do not benefit the community in positive ways.”

The letter also raised concerns with a perceived lack of maintenance of alleys by the city. While the project includes parking access through the alley that connects Charleville Boulevard and Gregory Way, Fischer stated that it won’t contribute to waste problems, as it utilizes an indoor trash collection system.

He also added that he believes the project will alleviate some of

the city’s perceived problems through generating revenue through rent.

“I understand [the Ibrahims’] complaints with respect to what’s going on in the city of Beverly Hills and development and etcetera, but none of [their] complaints particularly had to do with this particular building,” Fischer said. “While [they’re] concerned we don’t have enough money to fix potholes and things like that, I think that this building will provide ... a rental income for the city ... so hopefully some of that will do that.”

After questioning aspects of the proposal such as its decreased setbacks and balcony layout, Commission Chair Terri Kaplan, Vice Chair Jeff Wolfe and Commissioner Myra Demeter ultimately voted to approve the project.

“We did hear the residents who wrote us. And we do know that there are changes. And with the times, and with the different regulations that we have to follow coming from the state, we have certain flexibility – very little – but we do try to understand,” Demeter said.

# Richard Simmons dies at 76

■ Fitness guru leaves legacy of kindness

Few celebrities were more iconic than Richard Simmons, who died in Los Angeles on July 13.

The fitness guru came to prominence with a fresh approach to aerobic instruction, encouraging body-positivity and, most importantly, fun as part of the health and exercise wheelhouse. For decades, Simmons’ Beverly Hills studio was a fixture and his appearances on television were legendary, marked by his positive attitude and buoyant reserve of energy.

Born Milton Teagle Simmons in New Orleans on July 12, 1948, Simmons was raised in the city’s French Quarter and graduated with a degree in art from Florida State University. He changed his name to Richard in honor of his uncle, who paid for his college tuition. He struggled with weight growing up, which led to his inclusion as a “freak show” in the Federico Fellini films “Satyricon” (1968) and “The Clowns” (1970).

He moved to Los Angeles in the 1970s, working as the maître d’hotel at the popular Beverly Hills restaurant Derek’s. While there, he developed an interest in diet and exercise. He realized that there was a glaring need in the fitness industry for a supportive, inclusive environment to help everyday people lose weight and get healthy. Simmons took what he learned from his own weight-loss journey and launched a new kind of fitness environment with his Aerobics Asylum studio, which would eventually be christened Slimmons. With his quirky personality, he quickly gained a large following, which led to a popular 1980s talk show.

For clients and eventual friends like Elijah Jones, Simmons’ approach to exercise made a world of difference.

“I was born and raised in Hattiesburg, Mississippi, just two hours up the highway from where Richard grew up in New Orleans’

French Quarter,” Jones said. “Neither of us knew we were growing up barely 100 miles apart from each other and how our paths would cross. He was a fat kid from the French Quarter, me a fat Black kid from a small town in Mississippi. I continued overeating all the way through my adult life and eventually ended up weighing 484 pounds.”

But then Jones found Simmons. “I discovered Richard on television on ‘The Richard Simmons Show,’ right about the time I chose to take my life back from food and my weight. Watching Richard’s show was my inspiration and I eventually lost nearly 300 pounds,” he said. “I wrote a fan letter to Richard, telling him about my weight-loss success and how much his show had inspired me. As a result of that fan letter, I was flown to Los Angeles to be a guest on his show and share my own story with his audience.”

Jones ended up moving to L.A., working as a receptionist for Simmons’ show and, eventually, became his manager. Even after returning to Mississippi over a decade later, he kept working with Simmons and remained a life-long friend.

Jones’ story is not unique. The fitness guru had a gift for fostering community, and many clients became friends, including Los Angeles resident Liz Riley Pitman.

“Richard was so many things to so many people,” Riley Pitman said. “Everybody’s relationship with him was special and unique.”

Riley Pitman related that at one point, when she had lost a job, he offered to write a blank check for whatever she needed.

“I never took him up on it, but the fact that he had me up to his home and made the offer that meant a lot. I know I’m just one of many stories like that,” she said.

Marc Pasquinnelli never took one of Simmons’ classes and only encountered him one time, but his kindness is seared into Pasquinnelli’s memory.

“My friends and I were deep in the throes of putting together our costumes for West Hollywood’s Halloween Carnival [in 2013],”

Pasquinnelli remembered. “I went to Aardvark in Hollywood in search of a perfect trench coat for my Mary Poppins.”

He noticed Simmons’ presence in the store not long before he found the perfect coat to complete his ensemble, though the \$70 price tag was a bit steep for Pasquinnelli. But when he went to the register, the attendant told him that the coat had “been taken care of” – by Simmons.

“I have no idea how or when he did it, but he’d kindly paid for my coat,” he said. “I went right over to him and asked, ‘Are you sure?’ But he reassured me that he was happy to do it.”

This kind of kindness was just who Simmons was.

“Richard had a unique gift: making people feel good about themselves, no matter what they weighed,” Jones said. “He recognized the emotional baggage that came with being overweight but insisted that we not let it get us down. Richard made ‘fat acceptance’ OK before it became a thing, even in body-conscious Los Angeles. But his most special gift was his ability to connect with people across physical, economic and

social structure. He made the people who changed his beds at the hotel feel as special as the CEOs of those hotels.”

Jones said that he spoke to Simmons just before his death and reminded him of his “invaluable ability to make people smile and laugh.”

“He had the unique ability to take an hour of music and dance and turn it into magic,” Riley Pitman said. “I saw people change in so many ways physically, mentally. [There was] no one like him ... Slimmons was the second happiest place on Earth. He was a magic man.”

## State lawmakers offer views on homelessness, crime

## ■ Hollywood Chamber hosts State of the State forum

The Hollywood Chamber of Commerce held its annual State of the State forum on July 16 at the Hollywood Roosevelt Hotel, covering issues such as homelessness and crime that affect the local area as well as the entire city.

State Sens. Ben Allen and María Elena Durazo, and California Assemblymen Rick Chavez Zbur and Miguel Santiago, spoke during the luncheon, outlining state efforts to get people housed, reduce crime and improve quality of life. KTLA political reporter John Fenoglio moderated the panel discussion, which was attended by hundreds of Hollywood Chamber members.

“We’re in an election year and the four public officials that we have here, two assembly members and two state senators, the four of them together collectively represent all of what encompasses Hollywood. So they’re very important to our community,” Hollywood Chamber of Commerce president and CEO Steve Nissen said. “There’s real firepower that the Hollywood Chamber of Commerce is able to bring together all four representatives in one place at the same time.”

Santiago (D-Los Angeles) outlined some of the state programs that are impacting homelessness in counties and cities such as Los Angeles. He also called for more accountability to ensure state funds

are being spent wisely. Although the state faced budget deficits for the 2024-25 fiscal year, Gov. Gavin Newsom's budget allocates \$1 billion to address homelessness.

“That’s why we put a little bit more strong accountability in there,” Santiago said. “We made sure the counties and cities are using the dollars, they’re using data driven methods, not using it in particular ways that aren’t going to be effective.”

Zbur (D-Hollywood) said he believes efforts to address homelessness are moving in the right direction.

"I think it's getting slightly better. But one of the things I'm really optimistic about was that this year, we will maintain our commitment to funding programs that prevent homelessness," Zbur said. "Spending more money on homelessness prevention is really key to the things we need to do."

Allen (D-Santa Monica) added that he is pleased the governor devoted significant funding for efforts to end homelessness and also highlighted the need for more mental health treatment services. He said finding future funding for those will be challenging.

"I think that the budget challenges make the situation more vulnerable," Allen said. "That's why we all said, with the governor, we've got to retain this funding."

Durazo (D-Los Angeles) also cited mental health treatment as a much-needed component of addressing homelessness, and identified funding as a major challenge. "Another part that we know we

have to address much more directly is mental health services. That's a big part of addressing homelessness, and that's not just for the homeless, that's also for a growing number of youth that need mental health services," she said. "There's the piece of working with local governments and how do you push local governments to do the housing that's needed, build the health system that needed, but at the same time, take responsibility at the state level for funding. There has to be both and we've not exactly found that sweet spot."

Zbur said the Assembly is working on bills to better address homelessness that will be considered in the coming year. He is also working on measures to curb crime, particularly property crimes and retail theft, which are often intertwined with the homelessness problem.

"We actually have a very robust package of bills. It includes things like education and a new [law] that will make serial retail theft a felony. It will give police officers more enforcement tools for arresting people," Zbur said.

"I think what's important is that there is a holistic approach to the issue of retail theft. You have to be tougher in some ways to get the message across it is unacceptable, especially when we're talking about the safety of Californians. But we're also not going to be able to lock up our way out of this crisis," Durazo added. "We have to have the services that people need, but we also have to have a very direct and explicit way of addressing it."

Allen said he plans to address

property crime by creating measures targeting online marketplaces where thieves sell stolen merchandise. He advocated for more enforcement and new laws to hold people accountable who are organizing retail thefts, such as gangs and organized crime groups.

"In our last budget, a lot more money went out to our sheriffs and our [police departments] to be able to respond faster, because it doesn't matter how many new [laws] are on the books, if the police aren't there on time to help a store on the ground, it's not going to make your life better," Allen said.

Santiago said the goals need to be clearly defined and legislation targeted to specifically address

crimes. He cited the example of going after those who are organizing multiple retail crimes such as “smash-and-grab” robberies as opposed to someone who commits a “one-off.”

“One thing we haven’t talked about is the accountability piece of having law enforcement show up and actually make the arrest on someone. A lot of the footage that we’ve seen is people running in and running out,” Santiago said. “We took a look at this and actually asked the Little Hoover Commission (independent state commission on reform) to take a look at it and come back with a report about how is it that we really stop this particular issue.”

Marilyn Monroe offers no reason to celebrate

Re “Preservationists save Monroe home from demolition,” July 11 issue

I only learned about his when I read it in Beverly Press and found it to be a stunning development, one which I thoroughly reject as appropriate or reasonable.

“Few places help illustrate the life of Marilyn Monroe – and the person she was at this point in her life – better than her former Brentwood residence in Los Angeles.” Not so. Monroe only lived here for several months, and, by all accounts, they were probably the most miserable months of her life. She was depressed, confused, had been fired from her last job, her romantic life was a disaster, had purportedly tried to commit suicide only weeks earlier in Tahoe and was considered by some close to her to be mentally unstable.

This house does not represent the glamorous life of a famous movie star, but the end of the life of Norma Jean Baker. Marilyn Monroe was an illusion, a character of her own creation, a caricature of herself which she turned on and off at will and which the public turned into the movie icon and legend. She did nothing extraordinary, like contribute to science or medicine or anything else that could improve the quality of life for humanity.

She was a mediocre actress. “The fact that she passed away in the home gives this particular site an importance that no other site will ever have.” This was not Monroe's “life house,” it was her “death house” and that is not something to be celebrated. Comparing this

house to The Dakota in New York or to Graceland in Memphis is a bridge too far. There is no comparison and the ownership of someone’s personal real property was obstructed, as in this case.

“This is a site of an importance that no other site will ever have.” Except, the house is hidden from view behind walls on an out-of-the-way cul-de-sac that no one can visit or even look at. It’s also an unnecessary intrusion into the private lives of those who live in the neighborhood. Moving the house to a more public location is the only suggested option I can even partly agree with.

Monroe’s legend is her work, her movies, which have grown more popular through the years and will outlast everything else that commemorates her existence. Her crypt in Westwood has become a world class tourist draw. Millions of fans go there to be near her and leave little tokens of the love they feel for her, take pictures, attend a memorial service for her every year in the very same chapel in which her funeral was held, watch the 1962 black and white film of her funeral procession, listen to Lee Strasburg’s eulogy and “walk with the procession” from the chapel to her crypt. It’s the closest they can come to actually being there. Many of Marilyn’s closest friends, co-stars and associates have attended these memorials through the years.

These are the memories that keep the Marilyn Monroe legend alive and the closest they can get to the real person, none of which has anything at all to do with the “death house.”

Kings Road Park in WeHo should honor former resident

Re “Vintage: Kings Road Park opens in WeHo,” July 11 issue

That was a nice reflection about the park on Kings Road.

What surprised/saddened me about the location, was that no mention was ever made about who lived there for so many years. It was the home of Pete Larsen and his wife, since before I arrived there in 1964. He had that property, and another small A-frame unit that abutted the Dodge House.

He was always in his garden and you could hardly see the structure that is now the main clubhouse and restrooms. That used to be their home. He was kind of the unofficial watch dog over the Dodge House and was always chasing us kids out of there. It was wide open, no walls or fences. And we would walk our dogs down there to play and run on the enormous lawn. It was a glorious structure, and you can read about it on the monument that they’ve erected in its honor.

What bothered me, when they opened it, was that there was no mention of who lived there for so long. I don’t know how the transfer of the property was handled. I didn’t really get to know Pete Larsen, but he and my father had cordial conversations, and he knew that I was that little runt that he would chase off the Dodge House property, climbing onto the roof and exploring the jungle-like gardens.

At the time, I knew [former West Hollywood council member] Abbe Land, and wanted to

contact her and see what, if anything, could be done to remember Pete. A tiny plaque, something to remember him, and the years he spent taking care of that property while apartment buildings went up everywhere along Kings Road. There were some majestic homes there, as can be viewed just a block to the west of carefully zoned Kings Road.

We lived at 1028 N. Kings, a property owned by Dr. Max Wilson and his family. We leased the home there until my father’s passing in 1988. They sold the two lots for about \$4 million, and there is a big white box of condos there,

with the market’s loading dock to greet them each morning.

WeHo has more issues to deal with than remembering some long-forgotten family and who used to live where. We have the Schindler House, just down the street, and keeping it intact was a miracle in itself.

Pete Larsen would be pleased with the pocket park on Kings Road. Just would be nice if there was some memory of his name and the time he spent there.

Subway project prompts lane closures

The Los Angeles County Metropolitan Transportation Authority is offering updates about construction along the D Line subway extension project.

Street restoration work is ongoing at and around the existing subway station at Wilshire/Western and the new station at Wilshire/La Brea. Wilshire Boulevard is reduced to two lanes in each direction throughout July between Highland Avenue and Detroit Street to accommodate street-level work.

For approximately three months, a K-rail work zone will be implemented in the middle lanes of Wilshire Boulevard between Fairfax and Spaulding avenues, and Wilshire Boulevard will be reduced to two lanes in each direction in the area. A closure on Orange Grove Avenue south of Wilshire Boulevard will be removed, opening the street to northbound traffic. However, a construction fence west of the Fairfax Avenue intersection will remain in place.

Work is ongoing at the Wilshire/La Cienega station. Through Sunday, Aug. 4, Wilshire Boulevard will be reduced to a single lane in each direction overnight from 8 p.m.-7 a.m. between La Cienega and San Vicente boulevards. Eastbound Wilshire Boulevard will be intermittently closed overnight. The work supports ongoing waterline construction along Wilshire Boulevard. Northbound La Cienega Boulevard will also be reduced to

one lane overnight between Wilshire Boulevard and Clifton Way.

Crews are also restoring streets and sidewalks along Wilshire Boulevard near La Cienega Boulevard. A K-rail work zone will remain in place along the north side of the street.

Eastbound Wilshire Boulevard will be intermittently reduced to a single lane between Le Doux Road and Hamilton Drive from 8 p.m.-7 a.m. on weeknights, and 6 a.m.-10 p.m. on weekends to support access to underground areas near the Wilshire/La Cienega intersection.

At the Wilshire/Rodeo station, crews are working near South Beverly and Cañon drives. Construction is ongoing 24 hours on the subway station. Lanes on Wilshire Boulevard will be intermittently reduced between El Camino and Crescent drives. Lane reductions will also occur on Beverly and Reeves drives near Wilshire Boulevard.

At the Century City/Constellation station, crews are pouring structural concrete through September. A new traffic control plan to support utility relocation work is in place. Intermittent lane closures will occur on Constellation Boulevard through November.

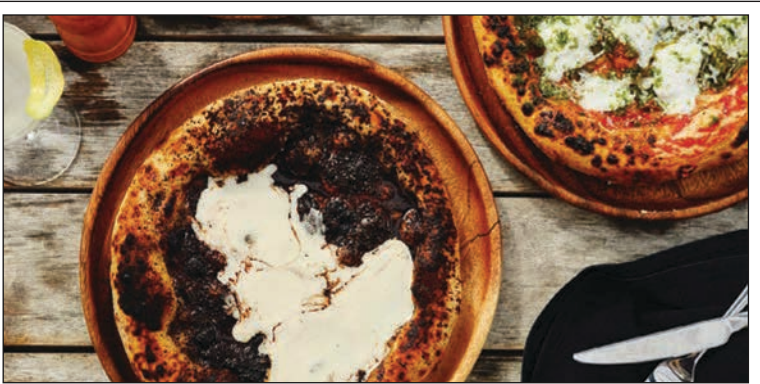

Many years and many beers later, Karl Strauss' award-winning brews are poured in bars up and down the West Coast, and it operates nine brewpubs, including one in Downtown Los Angeles. The location offers a casual respite in the heart of downtown, with an atmosphere that readily encourages tipping. Thirsty patrons can sit at booths, low and high-top tables, at the bar or even on couches, and catch the big game on multiple televisions. The quick, reliable service makes it a great pit stop to refuel before another commitment in the area – perhaps a pregame for a sporting event at the Crypto.com Arena or Dodger Stadium. It's also a great place to check in – and check out – after a long day of meetings in the city's financial district, or maybe even somewhere to go if you need to take a Zoom call while knocking back a few. There's plenty of space and it's relatively quiet, so long as you don't mind your virtual background being decorated with barrels, kegs and vats of

To start, I went for the duck fat pretzels. The bite-sized pretzel rolls are baked, tossed in the fat and dusted with rosemary, pecorino and parsley. They're an irresistible snack, especially when dipped in the accompanying truffle dip – a creamy garlic aioli – and eaten in between sipping a heavier, more bitter beer like an IPA. Duck fat is something of a rare find in many California restaurants. A novel state law prohibits serving foie gras, a luxurious French delicacy that is perhaps the most famous, if ethically questioned, way of consuming the animal's fat. Instead, this appetizer gives you just a hint of duck fat – a tastier, and in fact, healthier alternative to butter – and spares you of any moral quandary along the way.

The 5.1% ABV “Windansea Wheat Hefenwiezen” is a German-style wheat beer that’s still refreshing but packs a maltier punch.

Next was one of Karl Strauss' most well-known beers, the Irish-style "Red Trolley Red Ale." With its vibrant crimson color, the appearance is already markedly different than the previous two. At 5.8% ABV, it's richer, with a slightly fuller body and more obvious caramel notes. I still wouldn't call it a "heavy" beer, but it's more well-suited for a night at the pub than a day at the beach.

# ‘MaXXXine’ ends the ‘X’ trilogy on a high

Mia Goth is a star, to paraphrase Maxine Minx, save a naughty expletive. Now if you’re worried about a rogue F-bomb here or there, “MaXXXine,” the final chapter in the “X” horror series, might be a bit much. Like its predecessors, mood and style trump jolts, but gore rains down upon a 1980s Hollywood landscape.

First, 2022’s “X” explored horror cinema’s oft association with porn. Maxine (Goth) and a production crew attempt to create a hardcore film in a remote cabin, unaware of their landlords’ murderous proclivities, which would then be explored in prequel “Pearl.”

Several years later in the 1980s,

sole survivor Maxine rules the adult entertainment industry, but hopes to leave that all behind. She gets a shot, new hope found in a horror film. Is that on the nose? A horror flick shaking its own hand? Maybe, but consider all the stars whose careers began in horror, like Kevin Bacon, a campy private investigator in this meta-slasher.

Alas, Maxine’s chance at the limelight hits a snag. Someone seems obsessed with her. Is it the Night Stalker or someone trying to make a series of murders look like his work? Friends die, cops take notice and a mysterious, well-funded antagonist gets closer to his goal. That reveal is a satisfying one three

films in the making. Eventually, the body count adds up, but not before a slew of unexpected familiar faces grace the screen, including Giancarlo Esposito, as Maxine’s entertainment lawyer Teddy Night, Esq., and Elizabeth Debicki, as the director of “The Puritan II,” a film mired in controversy for both its religious content and casting an adult film star in a leading role. (Side note: Look up “MaXXXine’s” viral marketing stunt with protesters. It’s a fun tactic.)

These films are an actor’s sandbox. First, Goth plays both final girl Maxine and killer Pearl at the end of the 1970s. Then Goth fully embraces Pearl’s madness in a solo venture set nearly 60 years earlier. Now, Maxine takes center stage. She has some substance problems, but she remains focused on a singular goal: fame. Her performance doesn’t reach the memorable heights of “Pearl,” but it still allows Goth to do some remarkable acting.

In previous decades, Maxine would be an easy target, a horror

character violently discarded, punished for her sexual appetite and vain dreams. (Historically, horror films often elate in conservative morality that favors virginal survivors, after all.) Not so in “MaXXXine,” a film more interested in poking fun at the film industry, challenging horror norms.

This is yet another example of A24’s dominance in horror cinema. “Hereditary,” “Bodies, Bodies, Bodies” this year’s “I Saw the TV Glow” – the studio keeps racking up eerie, disturbing, clever contributions to one of the longest-running film genres. “MaXXXine” resides somewhere in the middle, poking fun at a slew of genres and tones while it tells a polished story as well.

For a third time, horror auteur Ti

West (“House of the Devil,” “The Innkeepers”) reminds us that horror is a ripe locale for creative exploration. Quentin Tarantino has known this for some time, and “MaXXXine” drives that home once more. It’s the most visually stunning “X” entry, overexposing its 1980s setting.

Think about perfect trilogies: “Back to the Future,” the original “Star Wars,” “The Lord of the Rings.” Add the “X” trilogy to that list. It’s a solid film, especially considering how many third entries cave to the pressure. The “X” films aren’t scary, but they know how to embrace style. “MaXXXine” ends the trilogy on a memorable note, exploring the peculiar connections between horror and porn and exploitation.

# City celebrates growth of childcare programs

Los Angeles Mayor Karen Bass’ Office of Economic Opportunity held a commencement for participants in the Early Childhood Education-Student Advancement Program on July 16.

The event celebrated the success and continuing growth of ECE-SAP – a program that recruits and trains early childhood educators – and highlighted the integration and expansion of the innovative Sesame 3G Mentoring Program.

“We are thrilled to celebrate the growth and success of the Early Childhood Education-Student Advancement Program,” Bass said. “This program has educated and inspired more than 200 community college students over the past two years. We’re additionally delighted that a newer component of ECE-SAP – the Sesame 3G program – has proven to be an asset to our community, fostering deep connections across generations. These are innovative solutions that strengthen our community bonds and drive the

recruitment of mentors and early-childhood educators.”

“This is a wonderful opportunity,” added Dr. Lewis Bernstein, founder and president of Sesame 3G. “We are very excited that our collaboration with the ECE-SAP program has been so successful that it has led to this expansion. By adapting our overall goals of three-generation engagement and mentorship to meet Los Angeles’ need for early-childhood educators, our Sesame 3G program helps build a community of support. This program addresses the needs not only of the preschoolers and fosters the development of a new generation of early-childhood professionals, but also provides an outlet for retired educators to give back and improve the field.”

ECE-SAP was developed by the Los Angeles Mayor’s Office of Economic Opportunity in 2021, in partnership with the Los Angeles Community College District and the Child Development Consortium

of Los Angeles. The program aims to increase the number of early-childhood educators through recruitment, coaching and certification, specifically targeting students interested in working with infants and toddlers. ECE-SAP offers mentorship guidance, financial awards, paid internship opportunities and career workshops to support students throughout their educational journey.

The collaboration with Sesame 3G brings together experienced early-childhood professionals, community-college students, and preschoolers. The educators mentor community college students, who in turn mentor preschoolers at child care centers throughout Los Angeles. Dubbed the Co-Generational Connection Program, the 3G initiative began as a pilot in 2022. It is expanding to include 30 three-person teams in its next cohort, engaging 90 participants.

## Westside Food Bank ensures children still get summer meals

Westside Food Bank’s Summer Children’s Nutrition Program replaces meals children regularly receive during the school year, ensuring children do not go hungry when school is out.

With the help of volunteers, Westside Food Bank prepares pre-packaged meal boxes of nonperishable food items that require little or no preparation, making them easy to consume for children. Each meal box, accompanied by a produce bag, contains the equivalent of 10 meals. The meal boxes include various nutritious items with a focus on protein and dairy, while the produce bags feature fresh fruits such as apples and oranges. Westside Food Bank’s partner agencies collect the pre-packed meal boxes and distribute them to families with

children alongside their regular food distributions.

“School’s out for summer, but hunger doesn’t take a vacation,” Westside Food Bank president and CEO Genevieve Riutort said. “[The] support nourishes bodies, nurtures hope and provides the stability children need to thrive. Together, we can ensure that every child in our community enjoys a healthy and happy summer.”

The food bank’s Summer Children’s Nutrition Program fills a critical need at a time when 30% of Los Angeles County households struggle with food insecurity, and 41% of those households include children under 18 years old. During the summer, many families do not have access to meals for their children, putting an additional strain on tight budgets.

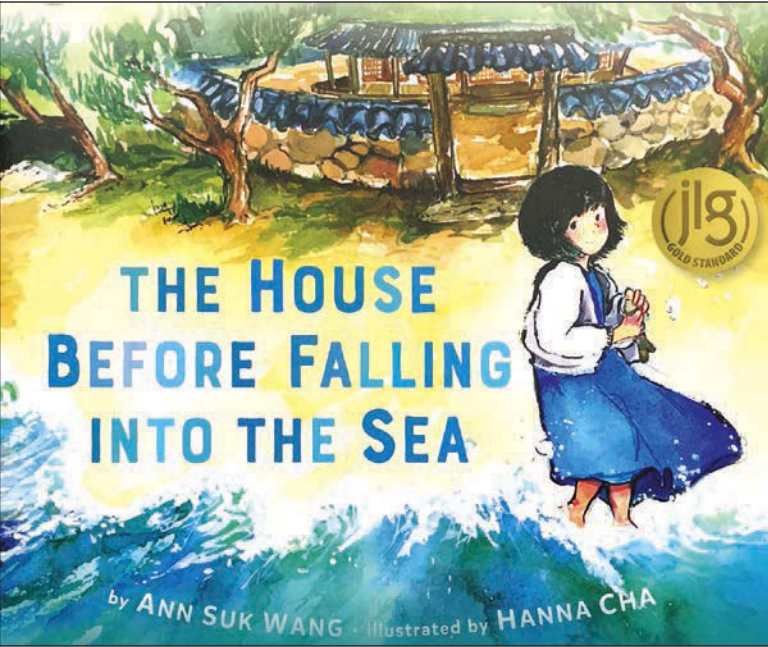

## L.A. students create performance inspired by Getty exhibition

# Getty acquires Flemish Renaissance masterpiece

On July 2, The J. Paul Getty Museum acquired at an auction in London “Madonna of the Cherries” by Quentin Metsys. Long believed to have been lost, the 16th century painting’s recent rediscovery offered Getty an opportunity to acquire one of the most significant paintings of the Flemish Renaissance to appear on the market in decades. The painting will go on view in the Getty Center’s North Pavilion in the coming weeks.

“The tender beauty and accessibility of Metsys’ representation of the familial bond between the Virgin Mary and Christ Child represents a major innovation in early Netherlandish painting that greatly heightens the emotional impact of the image,” Getty Museum Director Timothy Potts said. “Painted at the height of his career, and preserved today in excellent condition, ‘Madonna of the Cherries’ is among Metsys’ most appealing and influential compositions. Acknowledged as a masterpiece in its day, the painting became especially famous in the 17th century, after which its whereabouts were lost. I have no doubt that its spiritual and artistic resonance will make it one of the most beloved works in our collection.”

The painting depicts the Virgin Mary and child in loving embrace while seated on a regal throne. Christ, portrayed as a robust nude infant, wraps both arms around his mother’s neck and kisses her. The Virgin Mary firmly presses him to her breast and delicately flourishes a stem of cherries between the pinched fingers of her right hand. Through the large arched window at left, a Romanesque palace beside a lake is visible.

Rich with symbolism, the cherries have celestial connotations as the fruit of heaven, while their color signifies the future blood of Christ’s passion and sacrifice on the cross. The still life in the foreground elaborates on the theme of Christ’s future sacrifice, with a yellow apple referring to Christ’s role as the new Adam.

“This painting represents Metsys’ distinct personal style derived from his absorption of Netherlandish visual traditions and keen appreciation of significant Italian artistic developments,” said Anne Woollett, curator of paintings at the Getty Museum.

The first recorded owner of Madonna of the Cherries was prominent early 17th century art collector Cornelis van der Geest who, according to contemporary accounts, resisted efforts by the archdukes to obtain the painting from him. All traces of the painting were lost following its sale to an anonymous buyer in 1668. It resurfaced at auction in Paris in 1920 but was no longer recognizable due to several additions, such as a thick layer of discolored varnish and overpainting, including a green curtain painted over the background landscape. It reappeared once again in 2015 at a Christie’s auction, still marred by the later additions, and labeled as a studio version. After a subsequent conservation treatment, which revealed its exceptional quality and condition, scholars recognized it as the prime version of Metsys’ masterpiece.

This is the second painting by Metsys to enter the Getty Museum collection, following the 2018 acquisition of “Christ as the Man of Sorrows.”

# Merger may involve store closures

drastically reduce competition, exacerbate rising grocery prices and negatively impact thousands of workers.

“This supermarket mega merger comes as American consumers have seen the cost of groceries rise steadily over the past few years. Kroger’s acquisition of Albertsons would lead to additional grocery price hikes for everyday goods, further exacerbating the financial strain consumers across the country face today,” said Henry Liu, director of the FTC’s Bureau of Competition, in a press release. “Essential grocery store workers would also suffer under this deal, facing the threat of their wages dwindling, benefits diminishing and their working conditions deteriorating.”

The two companies released a list of 579 stores they agreed to sell to a third party as part of the agreement. The divestment is aimed at appeasing the concerns raised by the FTC and other antitrust regulators. The list includes 63 Pavilions, Vons, Albertsons and Safeway stores in California that will be sold to C&S Wholesale Grocers, a grocery supply company based in New Hampshire. The sale includes the Pavilions in West Hollywood at 8969 Santa Monica Blvd. and the Pavilions in Beverly Hills at 9467 W. Olympic Blvd.

While the future of the sale depends on the outcome of the federal lawsuit, C&S Wholesale Grocers said that if the sale goes through, current workers at Pavilions will keep their jobs.

“In order to ensure these stores continue to thrive, we will be welcoming hundreds of highly skilled grocery retail veterans and tens of thousands of store associates from Kroger and Albertsons who are currently responsible for these

stores,” said Lauren La Bruno, vice president of communications for C&S, in an email. “Their skill and knowledge, along with our leading wholesale and supply expertise will undoubtedly ensure that these stores continue to successfully serve their communities for many generations to come.”

Though C&S plans to acquire the two Pavilions, it is not clear under what name the two locations will rebrand. Additionally, La Bruno did not comment on specific plans for the Pavilions in West Hollywood and Beverly Hills, citing that the transaction is not final given the pending court cases.

However, the possible sale comes as the property owners for the Beverly Hills Pavilions location plan a development project that would vastly change the layout of the location. In March, the Aflalo Family Trust submitted a preliminary application for an eight-story, 110-unit mixed-use residential building with ground floor retail space, rooftop deck and three-level underground parking structure.

While a project of this scope would usually be prohibited in Beverly Hills, the developers are hoping to utilize the builder’s remedy, a state provision that allows developers to bypass local building restrictions when the proposal contains a certain percentage of affordable housing units and the city’s housing element does not meet state requirements. The proposed project at 9467 W. Olympic Blvd. reserves 22 units for low-income residents.

The project is being designed by Ottinger Architects, a firm that designed plans for a similar – and controversial – 19-story builder’s remedy project at 125-129 S. Linden Drive that has faced multi-

ple roadblocks in receiving approval from the city.

Property owner of the 9467 W. Olympic Blvd. site Sammy Aflalo said the current plans include space for a future grocery store on the ground floor. According to Aflalo, the future supermarket would face Olympic Boulevard, with separate retail businesses facing South Beverly Drive.

He said the lease for the current Pavilions lasts for another five years, and the property owners do not have the right to terminate the lease early to begin development. However, he said Albertsons expressed interest in terminating the Pavilions lease early if it could move into the redeveloped location, but added he is unsure exactly how the possible sale of Pavilions might affect the development plans.

“I really don’t know. As of a couple months ago we were talking to Pavilions ... and they said they wanted to be in the new site and that they were flexible on terminating their lease possibly earlier if we could work out a deal in the new site. We do have a space earmarked for a grocery store there. About 18,000 square feet of retail space that we’re designing so it’s appropriate for a grocer,” Aflalo said. “The idea was that [Pavilions] was going to give us some direction and let us know what their desires are for the space. I don’t know that that’s something they’ll do on behalf of C&S anymore. So it’s really up in the air. But we are going to develop the site and we are going to put the space in for a grocery store.”

Aflalo acknowledged potential pushback from nearby residents, but emphasized a commitment to completing the project.

“We do want to keep the com-

munity happy and we would be willing to make concessions in order for it to be well-received or as well-received as any development could be,” Aflalo said. “I know quite often that the community that might be resistant to the development ends up being patrons of the businesses and they end up loving it, so I know it’s going to be great for the community but I’m sure we will have some hurdles to overcome for it to be well-received by them.”

He also acknowledged potential challenges in getting the project approved by the city.

“I’m hoping that [the city is] becoming more realistic about what the laws are at the state level and how it applies to projects like this, because we do intend to build this, and we want to do it amicably with the city of Beverly Hills. But if they do oppose the project then we will take any remedies necessary in order to build it – any legal remedies,” Aflalo said.

The proposed project at the current Pavilions isn’t the only possible redevelopment in the immediate area. Aflalo said he has also

submitted preliminary applications for three other mixed-use development projects at the same intersection – a 10-story building at 9430 W. Olympic Blvd., a 10-story building at 9441 W. Olympic Blvd. and an eight-story building at 333-353 S. Beverly Drive. If approved, the four developments would significantly transform the intersection of Olympic Boulevard and Beverly Drive with over 350 new housing units.

“We wanted to really enhance the intersection,” Aflalo said. “Right now, they’re older buildings that don’t really operate properly – including vacant offices that just don’t really have as much of a need in this post-COVID era with remote work. And there’s obviously a housing crisis as well, so we’re eliminating obsolete offices and replacing them with much-needed housing, and eliminating an old grocery store that can’t really compete and operate with more modern grocers. We’re going to be able to deliver a product to a grocery store that’s state of the art, that will serve the community and will drive more revenue for the city.”

# Program expanded for public transit subsidies

The Los Angeles Department of Transportation, in partnership with Metro, is expanding the Universal Basic Mobility pilot program with phase II of the Mobility Wallet program.

The Mobility Wallet, the largest program of its kind in the nation, addresses systemic barriers to safe, efficient and reliable transportation for low-income Los Angeles residents. Mobility Wallets are pre-loaded payment cards that provide subsidies for transportation including public transit, ride-sharing services, micro-mobility, taxis and purchases at bike shops.

Phase I of the program, which ran from May 2023 to April 2024, provided 1,000 low-income residents in South L.A. with a prepaid debit card with \$150 per month to spend on transportation needs. Phase II of the Mobility Wallet program will identify 1,000 new, low-income residents within the South L.A. pilot zone, as well as an additional 1,000 low-income residents across L.A. County to receive the Mobility

Wallet subsidy. Applications for Phase II are open through Aug. 31 by visiting [metro.net/mobilitywallet1](https://metro.net/mobilitywallet1).

“As we urgently work to ensure that our transit system is safe for riders, we also must continue to expand access and reach to the communities that need it most,” Los Angeles Mayor Karen Bass said. “I commend LADOT General Manager Laura Rubio-Cornejo and Metro CEO Stephanie Wiggins for leading this important work.”

“LADOT is proud to continue advancing mobility equality with a new round of Mobility Wallets as part of our Universal Basic Mobility pilot program,” Rubio-Cornejo added. “Mobility Wallets empower individuals to choose the transportation solutions that work best for them. We’re excited to double participation in South L.A. – LADOT’s UBM pilot area – and expand this opportunity to residents across the county.”

To be eligible for phase II of the program, applicants must be 18

years old, live in L.A. County and may not have participated in phase I. The annual household income requirement is based on Metro’s Low Income Fare is Easy program. Participants will be randomly selected from all eligible applicants.

affect neighboring properties and the surrounding community. The replacement trees will take many years to mature and will not provide equivalent environmental value. Accordingly, the Planning Commission prejudicially abused its discretion when it found that there would be no adverse effects associated with the removal of these trees,” the appeal stated.

The decision will now be reviewed by the City Council in a meeting on Sept. 10.

The property at 1001 N. Roxbury Drive was bought by StubHub cofounder Eric Baker for nearly \$40 million in 2020. Prior to being a vacant lot, the property was home to a 1941 regency revival house designed by Carlton L. Burgess. The house was beloved by many local resi-

dents for its unique architectural style, but was demolished in 2022 despite public outcry. In 2022, the City Council voted 4-1 against granting historical status to the home, which would have prevented it from being demolished. Councilman John Mirisch was the lone vote in favor of preserving the house.

“It is often said home is a sacred place, and it’s not just the individual house that we live in,” Mirisch said following the council’s decision in 2022. “I think this is a sad day for Beverly Hills. I fear that today will go down in history as a moment when we ... failed our children and our grandchildren but also our parents and grandparents. From my perspective, 1001 Roxbury is indeed a remarkable, superior work.”

# Supervisor Hahn becomes chair of Metro Board

On July 10, Los Angeles County Supervisor Janice Hahn, 4th District, assumed the chair of the Metro Board of Directors and delivered a speech outlining her priorities for her year-long term with a

focus on safety.

“We know that new lines and stations will ultimately fail if riders’ top concern isn’t whether the Metro system goes where they need it to, but whether they will reach their

destination safely,” Hahn said to an audience of elected leaders and Metro employees.

Hahn spoke about her plan to ride Metro more often as chair.

“When my father was a supervi-

sor, he would take a different route to the office through his district every day. And every time he came across a pothole, he would report it to his staff and tell them that, the next time he drove that road, he expected it to be fixed,” Hahn said. “So, I am going to take a page out of my dad’s book. I haven’t ridden

Metro as much as I should have in the past, but I am going to make it a point to ride more while I am chair. And at our board meetings, I am going to talk about what I experience as a Metro rider. That will mean calling out problems I see, as well as praising the things that go right.”

Meister said.

“Public safety should be our No. 1 priority,” Councilman John Heilman said. “We need to give the sheriffs the technology they can use to prevent crime and to catch people who threaten our community. There have been too many armed robberies and residential burglaries in our community. Providing additional resources to the sheriff’s department will help them address this criminal behavior.

The program was approved in a split 3-2 decision by the City Council on July 15. The council authorized \$750,000 for technology enhancements that also include additional fixed cameras and a real-time watch center. A similar, permanent drone camera program already exists in neighboring Beverly Hills. City officials have touted the program as an innovative local security measure.

“We appreciate our partnership with the city of West Hollywood and the Los Angeles Sheriff’s Department and congratulate them for launching a pilot drone camera program,” Beverly Hills Police Department Chief Mark Stainbrook said. “This aligns with our commitment to using technology for community safety. Our drone program has been effective in preventing crime and responding to emergencies. West Hollywood’s initiative strengthens regional collaboration and our shared goal of maintaining a safe environment.”

In their dissenting votes, both Vice Mayor Chelsea Byers and Councilwoman Sepi Shyne cited concerns over public outreach on the issue.

“The technology package approved July 15 is a significant investment to make that will alter the way our city engages in law enforcement activity. It is my feel-

ing that this shift warrants an equally significant level of community engagement before full pursuit,” Byers said. “We are talking about surveillance technology and the subsequent privacy and civil rights issues at a scale totally new to our city. I wanted to see our city go above and beyond in terms of engaging our community on this topic, educating and creating awareness and providing meaningful ongoing opportunities where concerns and feedback can be addressed.”

“This is going to be an entirely different culture creation for the city of West Hollywood without enough public outreach,” Shyne said. “I would be more comfortable supporting this if we did a statistically-valid survey – a mailing out to all our residents letting them know there are going to be cameras up and down Santa Monica Boulevard and wherever else, and drones in use, with signs – that basically, the LGBTQ city of freedom is now becoming the city of Beverly Hills.”

But the council majority said that residents had already made their feelings clear.

“We have discussed this at a number of public meetings over the last few years,” Meister said. “We’ve also have had several public safety town halls, where residents and business owners have told us they don’t feel safe. Public safety is and should be the No. 1 priority of government. If we don’t have a pulse on that, based on constant community feedback, then the problem is not lack of meetings, it’s not hearing what people are telling us.”

“The public has spoken repeatedly about the need to address public safety,” Heilman said. “Unfortunately, residents and businesses who have raised these con-

cerns have sometimes been ignored. We can’t delay actions that could improve the safety of our community.”

Erickson said that the critique of “not doing enough outreach” was levied by residents who were upset about the direction to add bike lanes to parts of Gardner and Willoughby avenues.

“A few meetings ago, we were critiqued for not doing enough outreach about bike lanes and other transportation improvement measures, even though the facts show that we’ve been doing outreach since 2019 – and even before that,” Erickson said. “People can’t have it both ways, depending on what side of the proverbial aisle one is on regarding issues. The city has done outreach and, I would argue, goes much further than other cities with their approaches to community feedback. And, as I said, we plan to do a robust outreach program for the upcoming months before we roll out any of these programs so the community is well-versed in what we’re doing.”

Erickson added that the drone pilot program will be reassessed during the year it’s instituted, during which the drones will fly for 40 hours a week, although when those hours will be has not yet been determined.

“The city made one of the largest single investments in community safety ever,” Erickson said. “Public safety is a priority for everyone on the City Council. I appreciate how we all come to the meeting with varying opinions and parse our concerns and questions with respect for everyone.”

Specifics to the drone pilot program will be announced as it is rolled out over the next six months. Community updates are expected to be reported to the City Council throughout the process.

to a request for comment by press time. It is uncertain what the status of the development project is, or if it will even go forward as it was initially approved by City Council years ago.

Vice Mayor Chelsea Byers said that the situation is an example of a project getting tied up in development red tape.

“The project at the corner of Santa Monica and Doheny is an example of the consequences of delayed development,” Byers said. “We have to work as hard as we can to streamline and expedite new construction in our city.”

In regards to the proposed development, Councilwoman Lauren Meister said that the company is likely to return to the council for an amended or new development agreement.

“I’ll share my comments at that time. However, [I’m] obviously not happy about the new ecosystem growing in the hole we call the Melrose Triangle,” Meister said.

However, it is uncertain how long it will take for the area to be developed.

“Unfortunately, the city doesn’t own the lot, nor does the city have the authority to force someone to build,” Heilman said. “We have seen a number of development projects which are currently stalled due to high interest rates and challenges obtaining financing. It’s frustrating for the community and the council when projects don’t move forward. For projects with a development agreement, we are able to build in financial penalties which get imposed when the project doesn’t meet certain deadlines.”

“I encourage individuals to call the Charles Company and let them know your concerns and that you’d like them to finally move on building the project they promised – and were approved to do so by the City Council – years ago,” Mayor John Erickson said.

“People running for council should attend city meetings and reach out to leaders in the community,” Heilman said. “We always have several people who run who are well meaning but who have little history of involvement in the city and don’t seem to know much about the community and what the city does.”

Former Councilman John D’Amico has endorsed Hang and

offered advice to those running.

“There seem to be two kinds of candidates in this race: those that are yearning for an ill-defined moment in the past when everything seemed better, and those that know elections are always about making the changes we need to address the problems of today,” D’Amico said. “My money is on the candidates interested in today, not those pining for yesterday.”
